MedAcademy in Palestine: MedGeneration and Palestinian local actors create a National Diaspora Committee

The local seminar on Diaspora engagement, held on 30 November 2015 in Ramallah, brought together public and private Palestinian stakeholders to agree on a shared strategy towards Diaspora and define a concrete action plan, including priorities, team leaders and responsibilities. The event took place at the Palestine Trade Tower, under the High Patronage



of Abeer Odeh, Minister of National Economy for the Palestinian government. During her opening speech, she underlined the importance of engaging Diaspora to boost Palestine economic growth. The MedAcademy seminar gathered local stakeholders willing to participate in the design and implementation of a concrete and adapted strategy to engage Diaspora in economic development through mobilisation, investment, coaching and mentoring schemes: top local executives and managers from investment promotion agencies, economic development agencies, enterprises, banks, ministers, incubators, accelerators and entrepreneurship support networks.



Through brainstorming and working sessions, the final objective was to lead to an action plan, with concrete actions and defined actors in charge of their implementation. ANIMA and its local partners PIPA and PICTI followed a four-step methodological approach:

- Share insights to build a collective framework
- Define priorities and list objectives, players, actions
- Identify synergies for a shared action plan
- Turn ideas into concrete actions
